FY 2017 CDBG – Development of the soccer field

The additional funds have been approved. The County must advertise their intention to add funds so the public has an opportunity to comment. We should expect further notice from the County around mid-April.

Liquid Fuels

We are working on completing the MS999 (final) for the Pothole project completed in December. We are in need of a copy of a canceled check. If this is not paid in a reasonable time, PennDOT may disallow the cost, and the Borough will have to reimburse the Liquid Fuels account.

MS4 Separate Storm Sewer Permit

Has the Borough adopted the PRP agreement? The new NPDES permit will not be issued until the PRP agreement has been signed and forwarded to the DEP. Please note the EDCSC is looking for the Borough's annual membership payment.

Stormwater tip



Spring is right around the corner. Grass cutting will soon begin again. Cut grass at 2-1/2 to 3 inches tall so that clippings can decompose easily in the soil. Spare you stream systems by avoiding spring fertilization and leave grass clippings on your lawn. Grass clippings supply 25% - 50% of nitrogen and phosphorus needs. Mulched beds trap and infiltrate more rainwater than law or bare soil. Top off your garden with a thin layer of fresh mulch, making sure mulch does not touch tree bark, which will cause decomposition to the tree.

February Chief's Report

Dear Mr. President, Board of Directors, and General Membership,

During the month of February the company remained busy with calls for service, totaling 70, including 2 working fires, 1 in Darby Borough and 1 in Lansdowne borough.

On February 5th, Truck and Engine 4 responded to Lansdowne Borough to assist on a working apartment fire. Crews assisted with ventilation until released by Deputy 19. Crews operated on scene for approximately 60 minutes.

On February 8th, Company 4 was dispatched to 521 Pine St, in Darby Borough, for a building fire. Upon arrival crews were met with fire in the rear bump out of the building. Engine, Pipeline and Truck 4 all made the response. Members took care of fire suppression, searches and overhaul in the main fire building. Company 4 operated for 90 minutes until Chief 4 terminated command and made all companies available.

Mid-Atlantic was out to service our SCBA's, they repaired several SCBA brackets and flow tested all of them while doing the yearly PM service. All SCBA are functioning A/T/T. We are to use Energizer batteries from this point forward as that is what is recommended by Mid-Atlantic. They believe the corrosion in some of the battery compartments on the SCBA's came from the Duracell batteries we currently use leaking.

The engine was sent out for annual PM this month with nothing to report, the engine is in good condition. We are going to have the passing valve on the rear right discharge replaced at some point in the spring.


The Pipeline was also sent out for PM, Halo noticed a handful of leaking valves that needed to be replaced or fixed along with the pump packing needing long overdue attention. Halo was directed to make all necessary repairs before returning the vehicle to us. During the process halo noticed one of the struts holding up the hose bed was cracked, they are going to take care of this and have it fixed appropriately. They believe it can be from the rough roads in our town beating up on the vehicles and torquing the body. Prior to closing the pump panel Halo tested the pump packing and recorded the packing overheating when the vehicle was in pump, Halo called Waterous who stated theres either bushings dislodged or seal rings worn away in the bottom of the pump which need to be adjusted or replaced. Halo is waiting for a kit from Waterous to make necessary repairs on this. The pipeline is currently home and out of service until all matters are completely fixed.

Company 16 has requested that we run the Pipeline first out to 300 N. Front street instead of the ladder. Please remember this response order!

S.A.F.E.R grant, please continue to take shifts and get your availability to Dan Traband before the 15th of each month! Its important we cover these shifts a Thank you to the members who've been signing up to staff the apparatus, its very much appreciated!!

Darby #1 and Darby #2 were both dispatched to 34 incidents in Darby Borough in the month of February, including a WORKING FIRE. Darby #2 failed to respond to 28 of these calls totaling just under 83% of the calls. They also made no response to the aforementioned WORKING FIRE!
