### Ordinary Streets and Sewer Maintenance

We have a meeting scheduled for Monday, April 16th to meet with A to U about negotiation of the pricing for the storm portion of the bid. An update will be provided to Council at the meeting.

### Liquid Fuels

The MS999 reports are being completed for the open projects. These will be submitted to PennDOT.

### CDBG – 2017 Application

The plans will be advertised next week for the soccer field.

### MS4 Separate Storm Sewer Permit

The Notice of Intent has been delivered to the PA DEP.

Darby's annual contribution is estimated to be \$134,082. The Collaborative has discussed each town allocating 10% of the annual amount in 2018 with the successive years higher to make up the total required by year 5. It is suggested that the Borough budget as much as feasible, and \$13,408 as a minimum for MS4 compliance.

In order to complete the requirements for Year 4 of the permit, we will need information to be provided by the Borough. We sent a second the request to the Manager.

Please note that the Darby Town Center and the Darby Fire Co. No. 1 have not submitted inspection and maintenance reports as required by their Land Development approvals. The Borough will be held responsible for the non-compliance. It is suggested the Borough send a letter reminding these owners of their responsibilities. Penalties to the Borough can be as much as \$37,500/day.

### **Hazard Mitigation**

At the request of the Borough Manager, we submitted the Hazard Mitigation Assistance Program Monitoring Report.

### Streets Resurfacing

PennDOT has identified streets that are not currently on the Borough's liquid fuels listing. They are asking if we wish to pursue having them added. They include: Coventry Avenue, Londonderry Lane, Shetland Road, Glen Cove Road and Keystone Avenue. If the Borough maintains these roadways, we can pursue having them added to the approved listing, so we receive liquid fuels tax monies for them in the future. Please advise.

### Pedestrian trolley bridge

The structural engineer has inspected the pedestrian bridge and we are awaiting his report.

### **Signs**

We are finalizing collection of data in anticipation of the retroreflectivity testing.

### Stormwater tip

Spring can be a time of rejuvenation! But it's also a time for dirty jobs. To protect our waterways, rather than washing your vehicle of all that winter road salt in your driveway or on the street, take it to a local car wash. Commercial car washes have systems in place to clean the dirty water of pollutants that we don't have at our homes.

Mark and members of Council: I have learned about a workshop tonight about Act 135 also known as the Abandoned and Blighted Property Conservatorship Act which could be of substantial benefit to Darby. I will be going to that workshop and therefore will not be at the Council meeting tonight so I am sending this written report. Act 135 became law in 2008 and provides a mechanism for a court to appoint a conservator, under specified circumstances, to take charge of and transform abandoned and blighted buildings into productive re-use. I will report on what I learn. The link to the Act and other information is below.

We have started the process to again request a historical marker for Transportation Pioneer and Civil Rights Activist John Mott Drew. Previous request responses have indicated that although he is of great importance locally, we did not do enough to show his state-wide and national importance. <a href="http://www.darbyhistory.com/DrewMarker.html">http://www.darbyhistory.com/DrewMarker.html</a> A suggestion was made earlier for a locally designated marker which will be explored.

In other news, there has been some wonderful research done on Woodburne Mansion (aka Woodbourne, Villa St. Theresa, the Trumbauer Mansion on the Scott, Estate, and Little Flower Park. <a href="http://www.darbyhistory.com/LittleFlower-History.html">http://www.darbyhistory.com/LittleFlower-History.html</a>

Security for the site remains a concern and a suggestion has been made to locate the park construction office in the relatively undamaged kitchen wing to create a daily presence in the building and provide electricity for security lighting and fans to dry out the main building. A Friends of Woodburne group has been started and there will be a volunteer cleanup around the mansion on Saturday, April 28 beginning at 9:00 am in cooperation with the County Parks Department, the Friends of Woodburne, the Darby Creek Valley Association, Delaware County Community Services, the Collingdale Historical Society, the Darby Borough Historical

Commission, and others.

There will be a (Jane's Walk) walking tour of Darby called "The Darby You Don't Know" sponsored by the Preservation Alliance of Greater Philadelphia on Saturday, May 5th starting at the Darby Library at 11:00 am <a href="https://www.facebook.com/events/1832047053492541/">https://www.facebook.com/events/1832047053492541/</a>
