# CDBG - 2015 Concord Road Sanitary Sewer Replacement and Street Resurfacing

This project is completed.

# CDBG - 2016 Golf Road Infrastructure Improvements

The preconstruction meeting was held on December 15. The contractor intends to begin work during spring 2017.

### CDBG - 2017 Application

Grant applications were submitted on January 11, 2017. For the priority project, the Borough is seeking funding to continue sanitary sewer and street improvements on Golf Road. For the alternate project, the Borough is proposing the development of a regulation soccer field for the young people of the community.

### Storm Sewer Repairs

The storm sewer repairs at 2<sup>nd</sup> and Main Streets, 3<sup>rd</sup> and Main Streets, and 13<sup>th</sup> and Main Streets, and 422 Spruce St. have been completed.

During the installation of the concrete work at the 13<sup>th</sup> and Main Street intersection a sanitary sewer issued was discovered. Buck Frank excavated and made two repairs to the sanitary sewer system. Final restoration of this trench will be completed in the spring.

### MS4 Separate Storm Sewer Permit

We have started working on the Notice of Intent to renew the MS4 Permit and the Pollution Reduction Plan that must be submitted with the NOI.

PA DEP is hosting a workshop for Delaware County MS4s to discuss Total Maximum Daily Load (TMDL) Plan and Pollutant Reduction Plans (PRPs) requirements to help MS4s prepare their renewal NOI/ application, which is due on September 16, 2017. The workshop is January 19<sup>th</sup> at Springfield Township Building from 9am to 2pm.

Please note that the Darby Town Center and the Darby Fire Co. No. 1 have not submitted inspection and maintenance reports as required by their Land Development approvals. The Borough will be held responsible for the non-compliance. It is suggested the Borough send a letter reminding these owners of their responsibilities. Penalties to the Borough can be as much as \$37,500/day. We would like to prepare a letter for the Borough to send notifying both parties of the requirement and to give a date for when it must be submitted to the Borough.

### LED Streetlight Procurement

Financing conference call was held on January 11,2017 with additional information required to be submitted by the Borough by 1/13/17. Construction is expected to be during 2017.

### 842/844 Main St.

May marked 3 years since the fire occurred. Has anything been submitted by Mr. Healy regarding improving the site so the adjacent property owner can resolve their issues? The adjacent property owner has a sump pump connected to the sanitary sewer and this needs to be disconnected. It should be done as part of their building envelope improvement.

### **Demolitions**

143 N. 9<sup>th</sup> Street – the demolition grant application has been submitted to the County. OHCD indicates funding is limited at this time. The project will be included in the list provided to County Council for consideration during the FY 17 program review.

106 N. 6<sup>th</sup> Street – This is a private demo. On behalf of the Borough, Dan Honig, principal of Structures, Inc has met with and reviewed the revised permit application submitted by the demolition contractor. Please note that the contractor is to maintain contact with the Borough Code Department. Dan Honig will be available if there are any concerns; but, is not participating in active inspections of the activity.

611 Walnut Street – It has been weeks since the Borough Manager indicated the owner of the property (bank) has approved the contractor's proposal for demolition.

<u>109 N. 9<sup>th</sup> St.</u> – Dan Honig inspected the dwelling and will be submitting a report. His initial opinion is that it is not in danger of collapse; however, he does not think it can be rehabilitated for a reasonable price.

### Sanitary Sewer Grant Funds

The PA Small Water and Sewer Grant Application was submitted on October 31, 2016 for the replacement of 462 LF of sanitary sewer main and 52 laterals on Golf Road. The grant applications are being reviewed for completeness and will be forwarded to the Commonwealth

Financing Authority Board for review at their March 2017 meeting. NDI received a call from the reviewer and answered 4 questions. The reviewer indicated 600 applications were received.

### EP Environmental Education Grant -

The grant application for \$3,000 for the purchase and installation of storm drain markers was submitted to DCED on December 15, 2016. All awards will be announced on or around Earth Day, April 22, 2017.

### Chapter 94

The Chapter 94 reports are due in February. Worksheets and sanitary sewer maps were delivered to the Borough on January 10<sup>th</sup>.

### Stormwater tip

Never pour kitchen grease down the drain. Grease hardens against the inside of the pipes that carry sewage waste from your home, making the diameter of the pipe smaller. This can then cause sewage to get stuck in the pipes and then either backup into your house or spill out onto the street. If sewage goes onto the street, it is often carried to the storm drains when it rains. This ultimately means that <u>raw sewage</u> flows along our streets to nearby creeks and rivers. This situation is dangerous for member of the community and local wildlife. If you have grease left over from cooking, let the grease cool down until it hardens. Then you can put the grease in your regular trash. Be sure to wipe the grease from frying pans and cooking utensils before you put them in the sink to rinse or wash them.

As most of you are well aware we had Darby Fire Company #1's busiest year yet again totaling 612 dispatched incidents to Darby Borough and surrounding communities in the year 2016. Darby Fire Company #1 responded to a total of 24 "Working Fire's".

3 incidents stand out and should be brought up as once again Darby #1 stepped up to the plate and provided a great service.

On January 16th Company 04 was dispatched along with the Yeadon Assignment to 300 N. Front Street. Pipeline 04 arrived on the scene to find a 3 story multiple occupied dwelling with smoke showing. A young crew of 6 individuals stretched a hand line up to the 3rd floor to find an apartment

on fire. After making entry into the fire they heard voices from the rear bedroom. At this time the crew split and made a rescue of a younger female who was trapped in the back bedroom. Pt. was removed within minutes of the pipeline arriving on the scene of the incident. Patient was handed off to EMS crews just outside the front door of the apartment building. Patient was transported to the hospital via ambulance and made a full recovery.

On March 8th, Company 04 was dispatched along with the Building Assignment to the area of 522 Ellis Ave, Colwyn Borough for a Building Fire with Explosions. Both the Pipeline and Engine responded within seconds of dispatch to arrive to find a Working Fire. Multiple vehicles were fully involved in the rear of the property. About 10 minutes into the incident, it was noticed that the fire also consumed the interior of the warehouse. Fire reached a 2nd Alarm with multiple special calls including Claymont Fire Company out of New Castle County Delaware. Station 04 was in service for more then 7 hours that night.

On August 21st, Company 04 along with the Building Assignment was dispatched to 100 N. 3rd St, Darby Borough for the Building Fire with Entrapment. Delaware County Dispatcher's were on the line with a female who was trapped in the back bathroom of the 1st floor apartment. Patient was hiding in the bathtub and talking on the phone with the dispatchers telling them all the information. With great communication it was all relayed to Engine 04 while responding. Engine 04 arrived 2nd due behind Quint 21. Engine 04's immediately went into a search and rescue mode. Darby Borough Police assisted with keeping the fire in check while the crew made a rescue of an unknown aged female who was still hiding in the bathroom. Patient was safely removed and assisted out front to the awaiting crew of Medic 04-7A. Patient was transported to the hospital by ambulance and lately made a full recovery.

I would like to specially thank Station 16 (Yeadon Fire Company) on the strong support they show for our organization. Station 16 is dispatched along with us on each and every incident that occurs in Darby Borough. The relationship between the two continues to grow.
