Ordinary Streets and Sewer Maintenance

The Bid opening is scheduled for Monday, November 13, 2017 and will be held at East Lansdowne Borough at 9:30AM.

Motion to extend existing Ordinary Street and Sewer Maintenance Contracts to A to U Services, Inc., A. Gargiule & Sons, and A.F. Damon, Co., Inc. through December 31, 2017 is requested.

Liquid Fuels

PennDOT has approved the partial for the 2015-001 project. The final MS999 will be prepared as we have received the canceled check from the Borough. The 2016-001 project has been completed. The Partial can be submitted to PennDOT. Once proof of payment to the contractor has been received, the Final MS999 can be completed as well. It would be best to provide these canceled checks prior to December so that the project can be closed out before the MS965 will need to be completed.

CDBG - 2016 Golf Road Infrastructure Improvements

The change order was accepted and signed by the County. We are currently developing a letter requesting that the funding not used for this project remain available for the Borough's used and to allow for renewal of another segment of main replacement along Golf Road.

CDBG - 2017 Application

It is likely the County will issue the Notice to Proceed in October which will likely mean a spring construction schedule.

<u>CDBG – 2018</u> Applications

The application period for the 2018 round of CDBG funding is available. Applications are due to the County in January 2018. In order for an application to be submitted, an advertised public hearing must be to solicit input from the community on what applications to submit. Please

advise if you would like for the Engineer to advertise for this hearing. I'd suggest it be held on December 21, 2017, at 7:15PM, just prior to the Council meeting.

I am suggesting we reapply for the sanitary sewer replacement unfunded project from 2017 to continue the work from the 2016 CDBG funding on Golf Road.

As a reminder, the Borough has benefitted from CDBG funding over the past 3 years. In 2015, the Borough received funding to replace the main and resurface Concord Road; 2016 was the Golf Road project that is still being completed; 2017 we were awarded funding for a Soccer Field. Currently the Borough is awaiting a Notice to Proceed for this project. Finally, CDBG demolition funding was provided for the demolition of 313 Darby Terrace.

MS4 Separate Storm Sewer Permit

The Notice of Intent has been delivered to the PA DEP.

Darby's annual contribution is estimated to be \$134,082. The Collaborative has discussed each town allocating 10% of the annual amount in 2018 with the successive years higher to make up the total required by year 5. It is suggested that the Borough budget as much as feasible, and \$13,408 as a minimum for MS4 compliance.

In order to complete the requirements for Year 4 of the permit, we will need information to be provided by the Borough. We sent a second the request to the Manager.

Please note that the Darby Town Center and the Darby Fire Co. No. 1 have not submitted inspection and maintenance reports as required by their Land Development approvals. The Borough will be held responsible for the non-compliance. It is suggested the Borough send a letter reminding these owners of their responsibilities. Penalties to the Borough can be as much as \$37,500/day.

Streets Resurfacing

PennDOT has identified streets that are not currently on the Borough's liquid fuels listing. They are asking if we wish to pursue having them added. They include: Coventry Avenue, Londonderry Lane, Shetland Road, Glen Cove Road and Keystone Avenue. If the Borough maintains these roadways, we can pursue having them added to the approved listing, so we receive liquid fuels tax monies for them in the future. Please advise.

Pedestrian trolley bridge

The structural engineer has inspected the pedestrian bridge and we are awaiting his report.

842/844 Main St.

November 2017 marks 4-1/2 years since the fire occurred. Has anything been submitted by Mr. Bland regarding improving the site so the adjacent property owner can resolve their issues? The adjacent property owner has a sump pump connected to the sanitary sewer and it needs to be disconnected. It should be done as part of their building envelope improvement.

Demolitions

- 143 N. 9th Street the demolition grant application has been submitted to the County. OHCD indicates funding is limited at this time.
- 611 Walnut Street We are unaware of the status.
- 313 Darby Terrace The majority of the work has been completed. We are hopeful the project will be completed by the end of this month.

Sanitary Sewer

A section of sewer main has been replaced on Main Street in the vicinity of 735 Main Street where SEPTA had installed a pole through our pipe. The final restoration will be completed. Once this is finished, the Engineer will approve all invoices.

Sanitary Sewer Grant Funds

The PA Small Water and Sewer Grant will be announced for another round within the next few months. When the state budget was passed 2 weeks ago, funding for this program was approved. Dates for the application period along with guidelines for the program will be announced after November 14th.

Signs

We are finalizing collection of data in anticipation of the retroreflectivity testing.

Stormwater tip

Polluted stormwater is almost never treated, and it can be responsible for closing fishing grounds, threatening water resources, harming natural areas, and contributing to flooding!

Fortunately, there are many ways that you can help - don't dump, wash, or rake anything down a storm drain; sweep spilled fertilizers, grass clippings, leaves or soil off sidewalks and driveways and back onto the lawn; and where possible, divert rooftop runoff onto the lawn, rather than the driveway.
