ORDINANCE NO. #763

ADOPTING AND APPROVING AMENDMENT TO THE ARTICLES OF INCORPORATION OF DARBY CREEK JOINT AUTHORITY TO ADD A PROVISION THEREIN INCREASING THE TERM OF ITS EXISTENCE TO A DATE NOT EXCEEDING FIFTY YEARS FROM THE DATE OF APPROVAL OF THE ARTICLES OF INCORPORATION.

WHEREAS, an Amendment to the Articles of Incorporation of the Darby Creek Joint Authority has been proposed by the Board of said Authority, by a Resolution duly adopted on May 15, 2013, to add a provision to said Articles increasing the term of existence to a date not exceeding fifty years from the date of approval of the Articles of Incorporation; and

WHEREAS, the Borough of Darby is one of the municipalities composing the Authority; and

WHEREAS, the proposed Amendment has been submitted to this Municipality.

NOW, THEREFORE, BE IT ORDAINED THAT:

SECTION I: The Darby Creek Authority Board proposed Amendment to the Articles of Incorporation of Darby Creek Joint Authority to add the following:

"The term of existence shall be to a date not exceeding fifty years from the date of approval of the Articles of Amendment."

is hereby approved and adopted.

SECTION II: All Borough officials are authorized to take all action necessary to ensure implementation of and effect the purpose hereof.

SECTION III: Any and all Ordinances and/or Resolutions, or parts thereof, conflicting herewith are repealed insofar as the matters herein are affected.

SECTION IV: The provisions of this Ordinance are severable, and if any clause, sentence, subsection or section hereof shall be adjudged by any court of competent jurisdiction to be illegal, invalid or unconstitutional, such judgment or decision shall not affect, impair or invalidate the remainder but shall be confined in its operation and application to the clause, sentence, subsection or section rendered. It is hereby declared the intent of the Borough Council that this ordinance would have been adopted if such illegal, invalid, or unconstitutional clause, sentence, subsection, or section had not been included therein.

SECTION V: This is effective immediately upon enactment according to law, and shall remain in effect hereafter until revised, amended, or revoked by action of the Council of the Borough of Darby.
