FY 2017 CDBG - Development of the soccer field

We have issued an extension to the due date for the bids as contractors are asking questions regarding alternate approaches. It is possible we may have to reduce the size of the field to suit U-10 age group, unless permission is obtained from PECO to utilize their lot for spectators to use to watch the games. Is this something the Borough would like to pursue?

Liquid Fuels

Please provide a listing of pothole locations, or authorize us to identify locations throughout the Borough where potholes exist, so a project can be submitted to PennDOT in order to utilize the extra liquid fuels monies provided by the County.

Please note we require access to the PA DOTgrant system in order to upload the Resolution information to apply for the regular and extra County Aid monies for 2018. It is no longer done by hard copy. If we do not apply, the funds will not be made available to the Borough.

MS4 Separate Storm Sewer Permit

The Notice of Intent has been delivered to the PA DEP.

Darby's annual contribution is estimated to be \$134,082. The Collaborative has discussed each town allocating 10% of the annual amount in 2018 with the successive years higher to make up the total required by year 5. It is suggested that the Borough budget as much as feasible, and \$13,408 as a minimum for MS4 compliance. The Stormwater Collaborative will be sending the invoice for the first year's contribution towards the PRP commitment.

I have also attached information on the Rain Barrel workshops. Please make copies available for Borough residents and place on the Borough's website. There is a final workshop in East Lansdowne in June. It's free to the public, but registration is required up to a maximum of 50 participants.

10 Quarry St

I have not received additional information from the geotech retained by the property owner. It is understood that the Borough rescinded the permit for the work being done as of 5/4/18.

Streets Resurfacing

PennDOT has identified streets that are not currently on the Borough's liquid fuels listing. They are asking if we wish to pursue having them added. They include: Coventry Avenue, Londonderry Lane, Shetland Road, Glen Cove Road and Keystone Avenue. If the Borough maintains these roadways, we can pursue having them added to the approved listing, so we receive liquid fuels tax monies for them in the future. Please advise.

Pedestrian trolley bridge

The structural engineer has inspected the pedestrian bridge and we are awaiting his report.

Signs

We are finalizing collection of data in anticipation of the retroreflectivity testing.

Stormwater tip

After a very rainy month of May, here are a few reminders about stormwater. When rain hits the pavement, whether it's your driveway, sidewalk or street, it picks up and mixes with what is there. This could include:

- oil, grease, and automotive fluids;
- fertilizer and pesticides from gardens and homes;
- bacteria from pet waste and improperly maintained septic systems;
- soap from car washing;
- debris and litter.

Many assume that stormwater flows down storm drains and then to a treatment facility. That is not the case. Stormwater flows from the inlets directly into local waters, including the ocean. Do your part to prevent stormwater pollution. Do not put anything down a storm drain; clean up after your pet; take your car to a commercial car wash instead of washing at home; and minimize use of fertilizers and pesticides.
