FY 2017 CDBG – Development of the soccer field

The bid package is out for bid. At this time, the Bid Opening is scheduled for Wednesday, October 17th, 2018. We will review and evaluate all bids received and have a report to present to Council.

Liquid Fuels

We are finalizing the estimate and preparing the project application for the repair of various inlets. At the Borough's request, we are utilizing \$50K of the Borough's liquid fuels allocations. Other locations have been identified by Public Works and will be repaired when additional funds are available.

Sanitary Sewer

Would there be any follow up to the sinkhole at Concord Road and Main St. At the September meeting it was suggested that the sinkhole was in the vicinity of a recent project on Concord Road. We did check our files and the work done was the next block beyond Main Street.

MS4 Separate Storm Sewer Permit

The Borough's MS4 annual report was to the DEP on 9/28/18. The report was due on 9/30/18. As a reminder, the Borough should have received an invoice in July for the NDPES annual fee. This fee should have been paid by 9/30/18.

Has the Borough adopted the PRP agreement? The new NPDES permit will not be issued until the PRP agreement has been signed and forwarded to the DEP.

10 Quarry St

I have not received additional information from the geotech retained by the property owner. It is understood that the Borough rescinded the permit for the work being done as of 5/4/18. Do you want me to get the DCCD involved in this?

Stormwater tip

Fall is a busy time for homeowners in their yards. And, unknowingly, a homeowner can contaminate our waterways with fertilizer as they prepare their lawns for winter. Here are some tips to keep in mind when using fertilizer:

- 1. Use fertilizers sparingly. More application does not mean a greener lawn it means more watering and mowing.
- 2. Water the lawn with about 1/4-inch to 1/2-inch of water after a fertilizer application. This helps move the fertilizer into the soil and reduces the potential of being lost in stormwater runoff.
- 3. Never apply fertilizers if a heavy rain is anticipated.

If you spill fertilizers, sweep it up and place in the trash, do not hose or sweep them into the streets and storm drains.

Darby Fire Company #1 Boroughs Chief's Report September 2018

The month of October is Fire Prevention month and the members of Darby will be doing several fire prevention events and open houses.

- Colwyn Elementary School
- Joshua Tree Preschool
- Walnut Street School
- Children's Garden daycare
- Park Lane School
- Goodwill Fire Company Open House (Darby Twp.)
- Yeadon Fire Company Open House
- Prospect Park Open House

Darby Fire Company #1 is happy to once again participate in the Red Ribbon walk with Park Lane School later this month.

Daylight savings time will be ending Sunday November 4th and everyone is reminded that it's a good time to change the batteries in their smoke detectors.

I'd like to update Council on the situation with Darby Fire Patrol. As you're aware back in June I advise Council about the 5 members from there that joined our company. Since then we noticed a steep drop off in responses from Darby Fire Patrol. We have calculated the amount of calls in Darby and Colwyn because we're the recognized fire company for both towns. The numbers show the amount of calls that were dispatched, how many they responded to, how many were a delayed response and how many they didn't respond at all. The breakdown is as follows:

- June-September a total of 146 calls were dispatched in Darby and Colwyn
- 102 no responses
- 22 calls with a response time under 6 minutes
- 18 calls with a response time over 6 minutes
- 4 calls that they acknowledge but didn't respond (reason unknown)

I'd like to remind council that Darby #1 is doing the job of both fire companies on a consistent basis and that we take our job serious and work diligently to provide the very best service to the borough residence and visitors possible. I'd like to high light some of the things we've done to achieve that;

- Received a silver accredited certification from the PA State Fire Commissioners office which 75% of our active firefighters meet the nationally recognition in fire training. The actual percentage is in the upper 80%. The best that we can get is gold which 100% is and that's usually a career department.
- We also commit to weekly training that is conducted in house almost every Tuesday night starting at 7pm and ending between 930-10pm.
- Our average total responders per call reflects certified fire fighters per call and not the total amount of members of the trucks.

- Purchased a 100ft ladder truck back in January of this year because the ladder from Darby 2
 wasn't always available during calls. We'd need to rely on ladder trucks from Yeadon and
 Collingdale and we felt having our own would less that burden put on Yeadon and Collingdale.
- We received a Federal grant through FEMA to recruit and retain members. The grant will allow us to advertise on social media, proved us with lawn signs asking for members and a stipend for our current members. Members can sign up in blocks for a predetermined amount of time and at the end of that time they'll be given a stipend for those hours. This will translate into having members in the firehouse around the clock and ready to respond to calls within the borough and surrounding communities. This grant is at no cost to the tax payers of Darby.
- Were in the final stages to construct 12 individual bunkrooms to accommodate our members so
 that they can spend the night at the firehouse to eliminate the need to respond from home for
 calls.

Lastly I'd like to ask the members of council to recognize Darby Fire Company #1 as the sole fire company and emergency medical services for Darby Borough because of the inconstancies highlighted in this report with Darby Fire Patrol #2
