## **Current Month Activity:**

Ordinary Street and Sewer Maintenance

12<sup>th</sup>-13<sup>th</sup> Sts on Main – will schedule lining at the same time as the lining being done under 2021 CDBG to benefit from quantity pricing rate.

## Liquid Fuels

An ordinance must be passed by Borough Council that has the Borough adopt Londonderry Lane, Coventry Avenue, Shetland Road, and Glen Cove Road. If the Borough adopts these streets, than they can receive additional liquid fuels funds for the mileage of these streets.

## Grants

CFA Local Share Grant (Statewide): The Borough's application for grant funding to replace the sanitary sewer main and street laterals on North 2<sup>nd</sup> St. was submitted to DCED on 3/15/22.

2021 CDBG: The Borough has been awarded CDBG grant funds in the amount of \$238,299.00 and \$358,011 from the 2018 PA Small Water & Sewer Grant program to make sanitary sewer improvements on 13<sup>th</sup> Street from Main Street to the Darby Creek. Bids were opened on 5/11/22 at 9AM. One bid was received. We are working with the contractor to provide the County with pricing in the format they require. The Solicitor's letter documenting that the negotiated bid was completed in accordance with the Borough's procurement practice is also required by the County.

2022 CDBG: The Borough's application to do street improvements on 14<sup>th</sup> St between Main St. and the Darby Creek was submitted on January 7, 2022. The Borough received notice that County Council approved funding of this project.

2018 PA Small Water and Sewer Grant – this project is also being funded by the 2021 CDBG program; bids were received on 5/11/22, and with the Solicitor's approval, we are negotiating with the single bidder, Eagle Contracting. The Borough received an extension to the grant performance period through June 30, 2023.

Blight Remediation Grant: The demolition of 304 Marks Ave is nearing completion. The contractor is finishing stabilization and stucco application of 302 Marks Ave and will perform final grading, placement of topsoil, and seeding of the lot known as 304 Marks Ave. The

contractor has received the permit from CSX to use their parking lot at 6<sup>th</sup>/Main for a staging site for the demolition of 621 Main St.

## Code:

129/131/133 Whitely Terrace – The Structural Engineer and the contractor will be performing exploratory demo at two of these properties to determine structural details used during original construction. Depending on the findings of the exploratory effort, we will endeavor to obtain state funding to either stabilize or demolish these units.

MS4 (Municipal Separate Storm Sewer System): CCC with support from the Public Works Department will begin inspecting storm sewer outfalls next week. During each 5 year permit period, all outfalls must be inspected once. They are inspected for condition as well as any presence of a discharge when none should be found.

Act 167 Stormwater Management – An updated Stormwater Management Ordinance must be in place by mid-September. The County has prepared a proposed County-wide ordinance that is currently being reviewed by PA DEP (Department of Environmental Protection) for adequacy. The Borough will then proceed with adoption in accordance with the PA Borough Code.

Trolley Modernization Program – Septa held a virtual informational meeting to introduce key elements of the changes to be made. Trolley cars will be undergoing a change in configuration; stations and entry/discharge platforms will also be modified at many locations throughout the trolley system. ## Stormwater Tip:

**Water Pollution**: Sources of water pollution like industrial wastes from factories have been greatly reduced in recent years. Now, more than 60% of water pollution comes from things like leaking oil from cars, excess fertilizer, and pet waste. We can each do small things to help clean up our water. It starts with realizing that our sanitary and storm sewers are separate – what goes into storm drains flows directly into the environment, untreated.

What's the Problem with Auto Fluids? Auto fluids like oil do not dissolve in water. They last a long time and stick to everything from sand to bird feathers. Oil and other petroleum products are toxic to people, wildlife and plants. One pint of oil can make a slick larger thana football field. Oil that leaks from our cars onto roads and driveways is washed into storm drains, and then usually flows directly into a lake or stream.

## Facts and Figures:

- Oil, antifreeze, and break fluids contain heavy metals that can harm aquatic wildlife. The oil from just one oil change can pollute up to a million gallons of water!
- Used motor oil is the largest single source of oil pollution in our lakes, streams, and rivers. Americans spill 180 million gallons of used oil each year into our waters. This is 16 times the amount spilled by the Exxon Valdez in Alaska (the oil spill that killed at least half a million birds and other wildlife in 1989).
- If we refined the billion gallons of motor oil used every year in the United States, we would save 1.3 million barrels of oil per day, or half the daily output of the Alaskan Pipeline. According to the American Petroleum Institute, it takes 43 gallons of crude oil compared to just one gallon of used oil, to make 2.5 quarts of virgin lubricating oil.

## What we can do:

How can we use auto fluids and help keep our waters clean?

- Stop drips. Check for oil leaks regularly and fix them promptly. Keep your car tuned to reduce oil use.
- Use ground cloths or drip pans beneath your vehicle if you have leaks or are doing engine work. Clean up spills immediately. Collect all used oil and other fluids in containers with tight fitting lids. Do not mix different engine fluids.
- Use cat litter to soak up leaked oil, which can then be thrown in the trash once dry.
- Never dispose of oil or other engine fluids down the storm drain, on the ground or into a ditch. Dumping automotive fluids into storm drains has the same result as dumping the materials directly into a waterbody.
- Recycle used motor oil and other car fluids. Many auto supply stores and gas stations will accept used oil.
- Buy recycled (re-refined) motor oil to use in your car.
