**ORDINANCE NO. 808**

**2024 TAX LEVY, TRASH FEE AND SEWER FEE ORDINANCE**

AN ORDINANCE OF THE BOROUGH OF DARBY, DELAWARE COUNTY, PA, LEVYING REAL ESTATE TAXES; FIRE TAXES; LIBRARY TAXES; SEWER RENTAL AND USE FEES; REFUSE COLLECTION AND DISPOSAL TRASH FEE FOR THE YEAR 2024; AND, PROVIDING FOR 10% PENALTY AND 10% PER ANNUM INTEREST RATE FOR DELINQUENT REAL ESTATE TAX; FIRE TAX; LIBRARY TAX; SEWER RENTAL AND USE FEES; AND, REFUSE COLLECTION AND DISPOSAL TRASH FEES AND CONTINUING CERTAIN PREVIOUS TAXES.


1. **REAL ESTATE TAX LEVY:** A tax is levied on all taxable real estate situate in the Borough of Darby with a total tax rate on each dollar of assessed valuation of 15.65 mills comprised of: general purposes 14.60 mills; for fire control, prevention, equipment and maintenance purposes .75 mills; and for library purposes .3 mills.
2. **REFUSE/TRASH TAX:** The refuse collection disposal trash fee is \$395.00 per unit.
3. **SEWER RENTAL FEE/TAX:** The sewer rental and use fee is \$13.95 per 1,000 gallons of water usage.
4. **LOCAL SERVICES TAX:** The local services tax of \$52.00 per person, engaging in an occupation in the Borough is reenacted and continued for those individuals earning more than \$12,000.00 per year.
5. **REALTY TRANSFER TAX:** The realty transfer tax of 1% is reenacted and continued.
6. **EARNED INCOME TAX:** The earned income tax of 1% is continued.

7. **PENALTY:** A penalty of 10% and a 10% per annum interest rate, for all delinquent real estate taxes; fire taxes; library taxes; sewer fees; and, refuse collection and disposal trash fees is imposed.
8. **FAILURE TO RECEIVE TAX BILL:** The failure to receive a tax bill does not relieve a tax payer from the obligation to pay said taxes imposed herein.
9. **DISCOUNT:** A 2% discount is allowed, if the tax bill is paid on or before March 31, 2024.
10. **OTHER TAXES:** Further, all other taxes not inconsistent herein are reenacted, including costs of collection and attorney fees for delinquent accounts.
11. **SEVERABILITY:** If any part of this Ordinance is declared invalid, then the remaining parts or sections shall remain in effect.
12. **EFFECTIVE DATE:** The Ordinance will take effect immediately.


The Tax Levy and Budget for 2024 are hereby adopted this 20<sup>th</sup> day of December, 2023.


