Pledge of Allegiance.

Swearing in of Elected Officials by Judge Forbes & Judge Grimes. (Joar Dahn, Tracy Williams, Syretta Bullock, Alfred Robinson, Lucille Pratt, Dr. Omar K. Thompson and Tax Collector Donald Deigh)

Mayor Dahn called the meeting to Order at 5:47 p.m. followed by Roll Call.

Mayor Dahn, Councilors Bullock, Williams, Hill, Davis, Stockley, Robinson, Pratt, Dr. Thompson and Parks.

Appointment of Special Projects Engineer:

Dr. Thompson makes a motion to appoint Michael Galante as Special Projects Engineer; 2nd by Mrs. Parks. Motion carries 8-1. Ms. Stockley voted No.

Appointment of Vacancy Board Chairman:

Ms. Davis makes a motion to appoint Robert Smith as Vacancy Board (Chairman); 2nd by Mrs. Parks. Motion carries 8-1. Ms. Stockley voted No.

Appointment of Council President *Pro Tempore*

Mrs. Parks makes a motion to appoint Alfred Robinson as President Pro Tempore; 2nd by Dr. Thompson. Motion carries 9-0.
